What is NZPPA Payroll Certification

Designed to provide a framework for employees to assess their skill level and become a NZPPA Certified Payroll Professional

Matrix guidelines to consider your current level for application

The different levels provide a growth opportunity based on skill, knowledge, time and experience

Assessment to evaluate and confirm your level of experience and understanding

You must recertify every year – ensuring you keep current

It is not a course or webinar it is an assessment process

Certification Process which is Payroll Specific

- 3. CV Template Form. (or attach a current cv)
- 4. Organisation Chart and Job Description.

Keep an eye on the time




